## What is 10-ONE?

On November 6, 2012, City of Austin voters approved a City Charter Amendment commonly known as "Proposition 3" or "10-1." This Charter Amendment provides for the election of City Council Members from 10 geographic single-member districts, with the mayor elected from the City at-large beginning with the November 2014 election. The Amendment also provides for the creation of two entities:

- A 3-member Applicant Review Panel, and
- A 14-member Citizens Redistricting Commission.

The Applicant Review Panel selects a pool of the most qualified Commission applicants, from which the Commission is created. The Citizens Redistricting Commission is empowered to establish the boundaries of the 10 new council districts for the City of Austin.

## Why should I apply to serve on the Applicant Review Panel?

Members selected to serve on the Applicant Review Panel will make history by independently reviewing and selecting the most qualified applicants for service on Austin's first Citizens Redistricting Commission. Austin voters entrusted independent audit professionals with the duty to evaluate the Commission applications. The independent auditors selected to serve on the Applicant Review Panel will demonstrate and promote the auditing profession's core values of objectivity, independence, competency, and professionalism that drive their everyday work and service to our community.

## Why should I apply to serve on the Citizens Redistricting Commission?

Members selected to serve on the Citizens Redistricting Commission will also make history as the first citizen-initiated, independent entity to establish the boundaries of the 10 new City Council districts. Citizens Redistricting Commissioners will reflect the diversity of Austin and empower the citizens of Austin to have a voice for how our one City government represents us all.

## How can I apply to serve?

The application period is now open through February 22, 2013. Application forms can be found at the 10-ONE website and at selected City facilities throughout Austin. You may submit your application in one of three ways:

### What are the minimum qualifications to serve on the Applicant Review Panel\*?

1. Reside in the City of Austin
2. Currently licensed by the Texas State Board of Public Accountancy
3. Has at least 5 years of experience as a practicing independent auditor at some point in your career

### What are the minimum qualifications to serve on the Citizens Redistricting Commission\*?

#### A. Non-Student Commissioner:

1. Reside in the City of Austin.
2. Continuously registered voter in the City of Austin for the last 5 years
3. Has voted in 3 of the last 5 City of Austin general elections

#### B. Student Commissioner:

1. Reside in the City of Austin
2. Registered voter in the City of Austin
3. Enrolled at a community college or university located in the City of Austin

\* There are also disqualifying conflict of interest provisions that apply to both Applicant Review Panel and Citizens Redistricting Commission applicants.
