§4.02 of the Agreement requires Samsung's investment of \$2,500,000,000 by December 31, 2010. For the Second Ten-Year Period, §4.03 of the Agreement requires Samsung's investment of another \$1,000,000,000, for a total investment of \$3,500,000,000 by December 31, 2016. To remain eligible for the Second Ten-Year Period, §5.02 of the Agreement requires Samsung's investment of an additional \$500,000,000, for a total investment of \$4,000,000,000 by December 31, 2020. The City has verified Samsung's investment of \$4,688,496,479.64 during Years 1 through 4 of the Agreement. This investment fulfills Samsung's total investment requirement under the Agreement.

**3.0 Austin Energy (\$5.04.3)**
