Foodborne Illness FAQ's

What is foodborne illness?

Any illness that results from eating contaminated food.

What is a foodborne disease outbreak?

An outbreak of foodborne illness occurs when a group of people consume the same contaminated food and two or more of them come down with the same illness.

Who can get a foodborne illness?

Anyone can get a foodborne illness. However, some people are more likely to develop foodborne illnesses than others, including infants and children, pregnant women and their unborn children, older adults, and people with compromised immune systems.

How are foodborne illnesses prevented?

Foodborne illnesses can be prevented by properly storing, cooking, cleaning, and handling foods.

Tips for preventing foodborne illness in the home:

- Wash hands before handling foods and after handling raw meats and eggs.
- Thaw foods in the refrigerator or under cold running water.
- Wash all produce well before eating.
- Cook foods to the proper temperature and check with a thermometer.

The Centers for Disease Control and Prevention (CDC) estimates that 48 million foodborne illness cases occur in the United States every year. At least 128,000 Americans are hospitalized, and 3,000 die after eating contaminated food.
