# Resolution Direction

**Resolution No. 20130117-061** directed the City Manager to:

1. Identify and take preliminary steps to authorize a General Obligation Bond Proposition for affordable housing;
2. Review previous practices of the City of Austin and best practices of other cities to identify long-term sources of funding for affordable housing; and
3. Report back to Council no later than February 14, 2013, with a timeline for required actions, stakeholder presentations, public input and briefings to the City Council including various topics related to affordable housing.

# Relevant Definitions

## Affordable Housing:

Housing in which the occupant(s) is/are paying no more than 30 percent of his or her income for gross housing costs, including utilities.

## Household Affordability (Imagine Austin Priority Program #6):

Household affordability takes into consideration the costs of housing, utilities, taxes and transportation.

## Based on Median Family Income:

30% of Median Family Income:	\$15,400 for 1-person household; \$21,950 for a 4-person household
50% of Median Family Income:	\$25,650 for 1-person household; \$36,600 for a 4-person household
80% of Median Family Income:	\$41,000 for 1-person household; \$58,550 for a 4-person household

1. Staff Working Group comprised of Law Department, Finance Department, Capital Planning Office, Public Information Office, NHCD, HHSD
2. Proposed election timelines and scenarios for future General Obligation Bond election distributed to Mayor and Council
3. Future Worksession briefings to provide requested information
4. Community Outreach Plan in partnership with the Capital Planning Office and the Public Information Office
5. Best Practices Report identifying other cities' approach to short-term and long-term sources of funding for affordable housing

- Last regularly scheduled Council meeting is August 22, 2013

May 10,  
2014

- Feb. 28, 2014 is the last date to call an election
- 2014 Council schedule has not been set

Nov. 4,  
2014

- Aug. 18, 2014 is the last date to call an election
- 2014 Council schedule has not been set

-  Comparative practices undertaken by peer cities to provide the community with voter information  
(NHCD/Capital Planning Office with review by Law Department and bond counsel)
-  Recap of 2012 Bond Advisory Task Force work and community input from the Imagine Austin and 2012 bond development efforts (Capital Planning Office)
-  Update on current plans for tax ratification and/or bond elections of other governmental jurisdictions within the City of Austin (Capital Planning Office)
-  Briefing on City of Austin Debt Capacity (Finance Department)



# Requested housing topics

- Affordable housing needs assessment and Return on Investment (ROI)
- Affordable housing best practices to include information on dedicated revenue, regulatory practices, and setting affordable housing targets and goals.
- Siting affordable housing in Austin to include an overview of the current scoring matrix and siting practices
- Funding opportunities through the Housing Trust Fund and overall short term & long term funding recommendations for affordable housing

- City Council direction for implementation of possible election timeline and activities
- Initiate Community Outreach Plan with communications partnerships
- Incorporate community engagement efforts to support Imagine Austin Household Affordability education
- Develop presentations for future briefings to include community and organizational partners.
