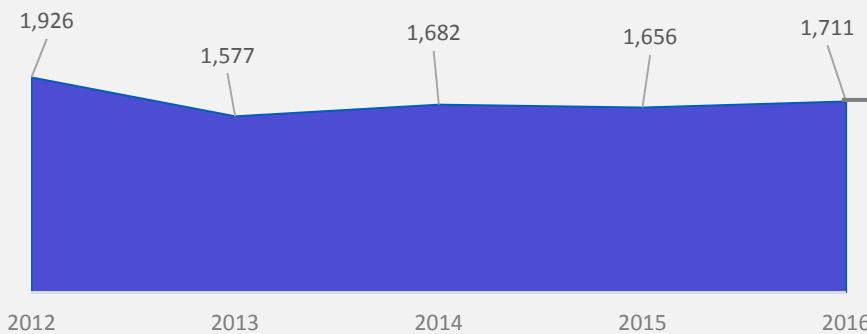

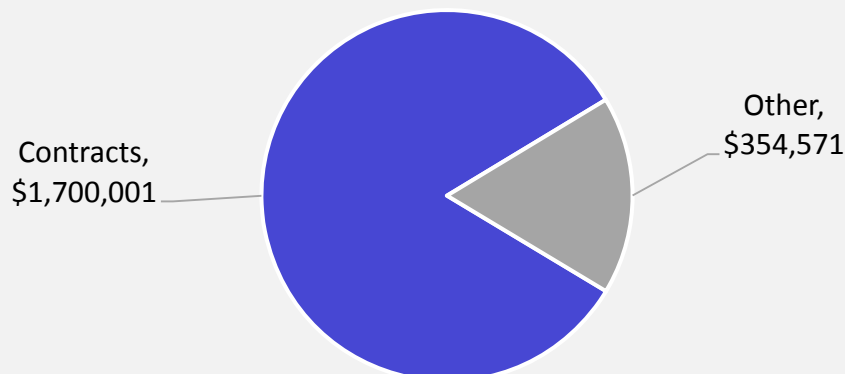

## Breakdown of Community Development Budget



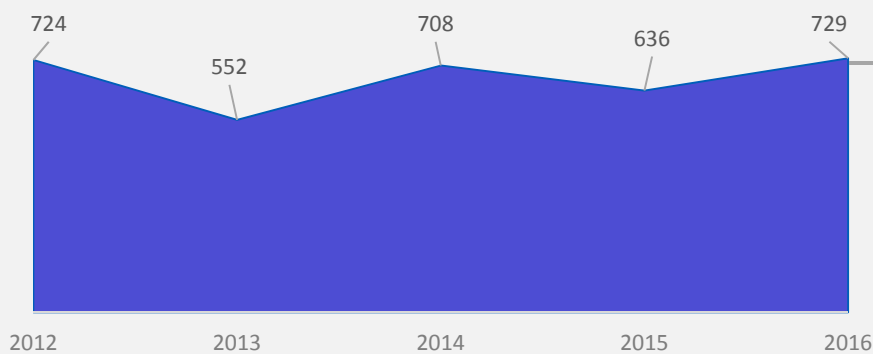
# Homebuyer/Homeowner Assistance

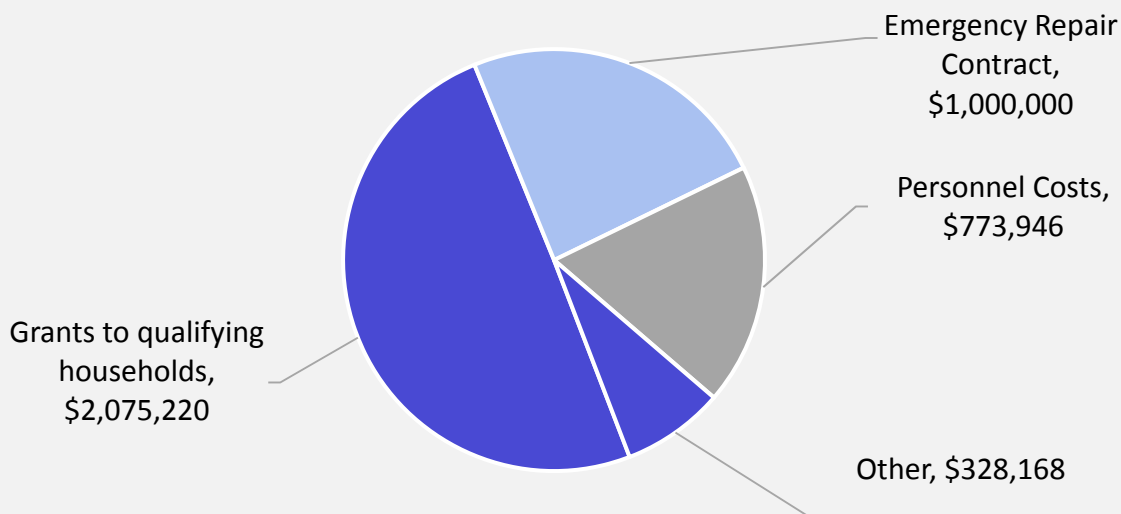

## Breakdown of Homebuyer/Homeowner Budget

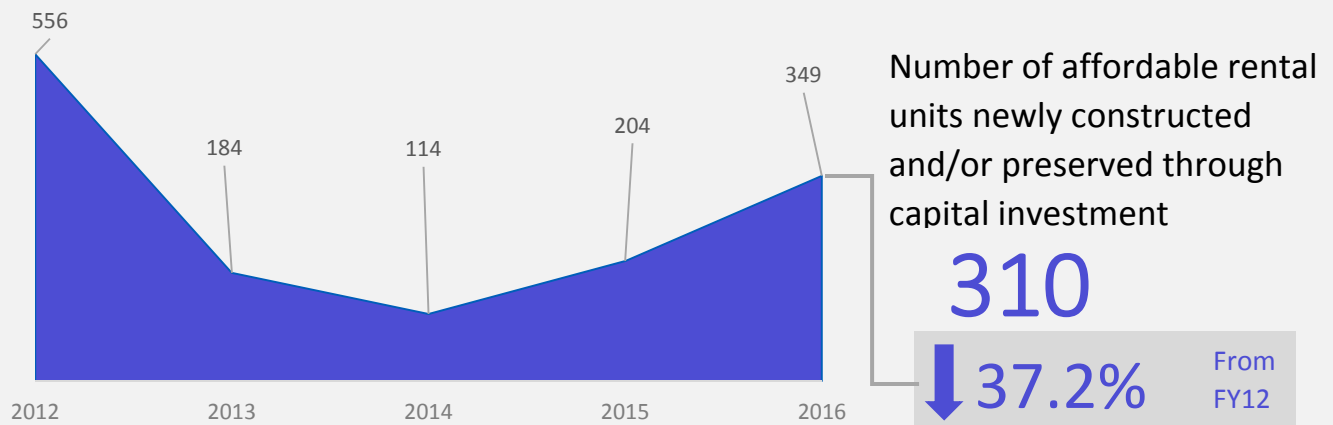


# Housing Developer Assistance

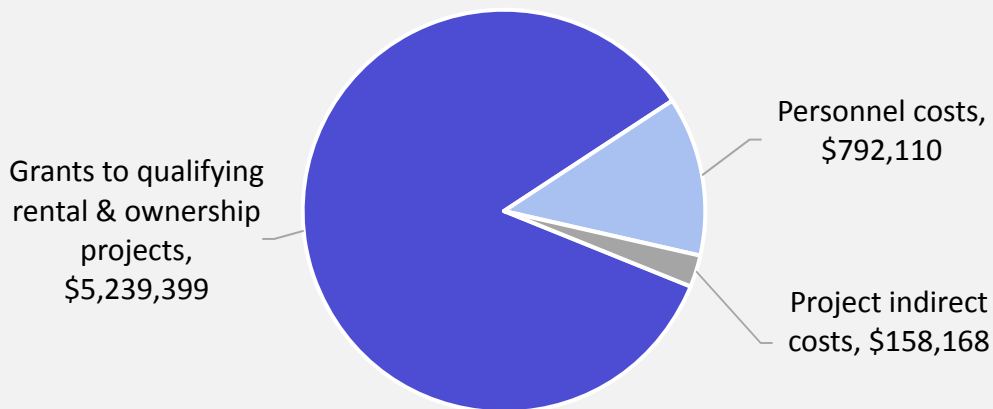

## Breakdown of Housing Developer Assistance Budget

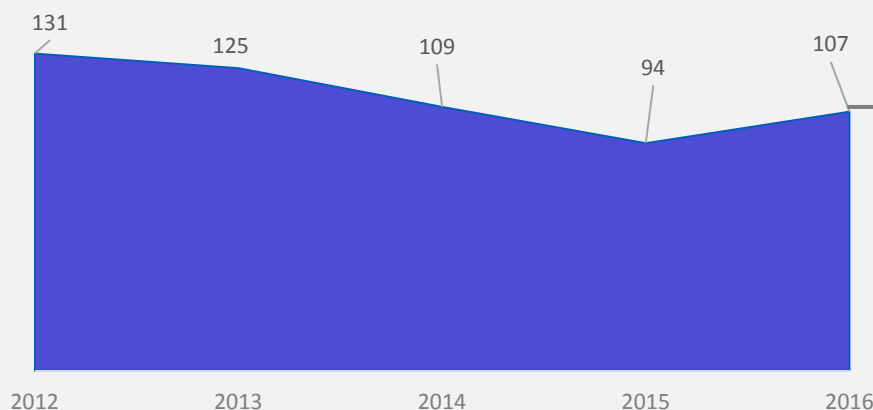


# Renter Assistance
