NOTICE OF PROPOSED RULE

POSTING DATE: October 3, 2012

The Director of the Planning and Development Review Department proposes to adopt the following rule after November 4, 2012.

Comments on the proposed rule are requested from the public. Comments should be submitted to Sylvia Arzola, 505 Barton Springs Road, Suite 500, (512), 974-6448. To be considered, comments must be submitted before November 4, 2012, the 32nd day after the date this notice is posted. A summary of the written comments received will be included in the notice of rule adoption that must be posted for the rule to become effective.

An affordability impact statement regarding the proposed rule has been obtained and is available for inspection or copying at the address noted in the preceding paragraph.

EFFECTIVE DATE OF PROPOSED RULE

A rule proposed in this notice may not become effective before the effective date established by a separate notice of rule adoption. A notice of rule adoption may not be posted before November 4, 2012 (the 32nd day after the date of this notice) or not after January 2, 2013 (the 90th day after the date of this notice).

If a proposed rule is not adopted on or before January 2, 2013, it is automatically withdrawn and cannot be adopted without first posting a new notice of a proposed rule.

ˆBRIEF EXPLANATION OF PROPOSED RULE

Rule R161-12.32: Revisions to Local Historic District Nomination Application- the proposed revisions outline the instructions for submitting and receiving approval for rezoning of an area as a Local Historic District (“HD” zoning overlay), clarify and revise the submittal, review and approval requirements for submitting a request to rezone an area as a Local Historic District, and provide direction for researching the history of an area, developing a historical context, and documenting the historic and current character of a potential Local Historic District.

AUTHORITY FOR ADOPTION OF PROPOSED RULE

The authority and procedure for adoption of a rule to assist in the implementation, administration, or enforcement of a provision of the City Code is provided in Chapter 1-2 of the City Code. The authority to regulate residential building review is established in Chapter 25-2 of the City Code.
