### SERVICE DISABLED VETERAN BUSINESS ENTERPRISE PROGRAM

Based on the findings from the 2016 Disparity Study, The Capital Contracting Office (CCO), the Small and Minority Business Resource Department (SMBR), and the Purchasing Office began discussions of the feasibility of a procurement program to begin addressing the need to improve access to City of Austin contracting opportunities for Service-Disabled Veterans. These discussions led to the development of the interim Service Disabled Veteran Business Enterprise (SDVBE) Program.

This program will be launched as a pilot for formal solicitations using Request for Proposals (RFPs) to be released on or after October 1, 2017. The SDVBE program will provide a 3% preference to State Historically Underutilized Business (HUB) certified Service Disabled-Veteran-Owned Businesses. The preference will only apply to the prime contractors responding to RFPs and not to any subcontractors they may be using.

The interim program will run for a period lasting no longer than 24 months to allow for data collection and review of best practices to determine long-term implementation.
