Dear Stakeholders:

At the December 13, 2018 Austin City Council meeting, the Small & Minority Business Resources Department (SMBR) brought forward for City Council consideration a request to contract with Colette Holt & Associates to conduct a new disparity study. City Council directed staff to conduct stakeholder meetings in January 2019 for the purpose of receiving comments on the proposed scope of work for the Disparity Study. The stakeholder comments received at these meetings will be presented to the MBE/WBE Small Business Enterprise Procurement Program Advisory Committee at its February 5, 2019 meeting, with the item to retain Colette Holt & Associates returning for Council consideration at their February 21, 2019 City Council meeting. The City has conducted several disparity studies over the last 25 years, to correctly identify the areas of disparity and remedy them with the MBE/WBE Procurement Program. The scope of work for a disparity study must meet federal constitutional and judicial requirements and should conform to prescribed best practices that have withstood challenges in the court system. A disparity study includes two types of information: qualitative or anecdotal information, in addition to quantitative information (City expenditures). The qualitative and anecdotal data will be gathered from interviews with our stakeholders in the local, small, minority and women-owned business communities and non-certified firms. Quantitative information will be drawn from the City's internal contract databases based on expenditures for the study period (2013-2018) and will be analyzed by the consultant.
