DESCRIPTION: Service Saddles (for tapping potable and reclaimed water services) shall comply with the

following:

1. AWWA C800, where applicable

2. Minimum pressure rating 200 psi

3. 12-mil nylon-coated ductile iron or stainless steel outlet

4. Flat stainless steel band (single or double straps)

5. Bolts and nuts shall be stainless steel or high-strength low-alloy steel (HSLA). All bolts and nuts shall be coated with a blue fluoropolymer finish.

6. Sizes are 4" x 1" through 24" x 2" for DI or PVC C900 pipe O.D.

7. NPT threaded outlet

8. NSF 61 approved gasketing
